NOW IT IS HEREBY AGREED as follows:

- 根據下述條款, 業主同意出租而租方同意租入下述物業。  
The Landlord agrees to let and the Tenant agrees to take the premises hereinafter mentioned on the following terms and conditions.
- 物業地址  
Address of Premises **青山公路潭尾段18號**  
**PHASE 3**
- 每月租金  
Monthly Rental 港幣 **5,000.00** (\* 不包括地租, 差餉及管理費), 以上期形式每月支付。  
HK\$ **5,000.00** \*( Exclusive of Government Rent, Rates and Management Fee). Payable monthly in advance.
- 按金  
Deposit 港幣 **10,000.00** 於簽署正式租約時或以前支付。  
HK\$ **10,000.00** To be paid on or before signing of the formal tenancy agreement.  
上述按金業主將於租約終止時無息退還予租方。  
The deposit shall be refunded to the Tenant by the Landlord without interest on expiration of the tenancy.
- 初步訂金  
Initial Deposit 港幣 **5,000.00** 於簽訂本合約時支付予業主, 而此初步訂金將作為按金之部份款項。  
HK\$ **5,000.00** To be paid to the Landlord upon signing of this agreement, and it shall be applied as part of deposit.
- 租期  
Term of Tenancy 由 **04/11/2024** 至 **03/11/2025**

- 退租權  
Break Clause 儘管與前文不符, 任何一方可給予 另一方 不少於 一個月 的書面通知或 一個月 租金作代通知金提早解除此租約; 唯該書面通知書不得早於由租期起計之 [十一] 個月內發出。  
Notwithstanding anything to the contrary hereinbefore contained, either party shall be entitled to terminate this Agreement earlier than as herein provided by serving not less than 1 months' written notice or by paying 1 months' Rent in lieu to the other party provided that the said written notice shall not be served before the expiration of the 11 months of the term residency.
- 於 **04/11/2024** 或之前, 業主須將該物業交吉予租方。  
On or before **04/11/2024**, the Landlord shall deliver vacant possession of the said premises to the Tenant.
- 該物業除作為 **居住** 用途外, 不得作其他用途。  
The said premises shall not be used for any purposes other than for **居住** purpose.
- 租方在租期內不得將該物業或任何部份轉讓或分租或將其使用權轉交予他人。  
The Tenant shall not assign or sublet or part the possession of the said premises or any part thereof during the term of tenancy.
- 交吉前有關該物業之雜費(包括水、電及煤氣費, 管理費、差餉及地租)由業主負擔。  
Before delivery of vacant possession, all expenses of the said premises (including water, electricity and gas charge, management fee), rates, and Government rent) shall be paid by the Landlord.
- 於 **08/11/2024** 或之前, 雙方須於 **Tin Chi Property Agency**  
On or before **08/11/2024**, both parties shall sign the formal tenancy agreement at **Tin Chi Property Agency**

- 雙方須各自負責其律師費而正式租約的釐印費由雙方各半負擔。  
Each party shall pay its own legal costs but the stamp duty payable on the formal tenancy agreement shall be borne by both parties in equal shares.
- 如租方未能履行本合約之條款租入該物業, 業主除將租方已付之初步訂金沒收外, 並有權將該物業出租予他人, 惟業主不可再為此向租方追究任何賠償或特定履行。  
Should the Tenant fail to take up the tenancy of the said premises in the manner herein contained, the initial deposit shall be forfeited to the Landlord and the Landlord shall then be entitled at his absolute discretion to let the said premises to anyone he thinks fit and the Landlord shall not take further action to claim the Tenant for damages or to enforce specific performance.

15. 如業主在收取初步訂金後,不依本合約條款將該物業租予租方;業主除需即時退還租方所付之初步訂金全數外,並需賠償一筆同等於該初步訂金數目之金額與租方。惟租方不得再向業主追究任何賠償或特定履行。  
Should the Landlord after receiving the initial deposit paid hereunder fail to let the said premises to the Tenant in the manner herein contained, the Landlord shall immediately refund the initial deposit to the Tenant and shall compensate the Tenant with a sum equivalent to the initial deposit and the Tenant shall not take further action to claim the Landlord for damages or to enforce specific performance.
16. 基於代理在促成該物業租賃中提供之服務,代理有權向業主收取港幣 2,500.00 並向租方收取  
In consideration of the service rendered by the Agent, the Agent shall be entitled to receive HK\$ 2,500.00 from the Landlord and

17. 無論在任何情況下,若業主或租方未能履行本合約之條款出租或租入該物業,則悔約的一方須即時付予代理港幣港幣  
If in any case either the Landlord or the Tenant fails to let or take up the tenancy of the said premises in the manner herein contained, the defaulting party shall compensate at once the agent HK\$ 5,000.00 作為賠償代理之損失。

18. 如業主及租客在簽署本合約後未得代理書面同意下達成協議取消本合約所涉及的交易,業主及租方雙方將需在交易取消時即時各自負責支付代理根據本合約第十六條各自所需負責的佣金及費用。  
In the event that the Landlord and the Tenant shall after the signing of this Agreement agree to cancel the transaction under this Agreement without the prior written consent of the Agent, each of the Landlord and the Tenant shall upon cancellation of the transaction forthwith be liable to pay the Agent the commission and fees payable by them under clause 16 of this statement.

It is hereby declared that the Agent is the Agent for **both the Landlord and the Tenant.**

If there is any conflict between the English version and the Chinese version in this Agreement, the **English** version shall prevail.
